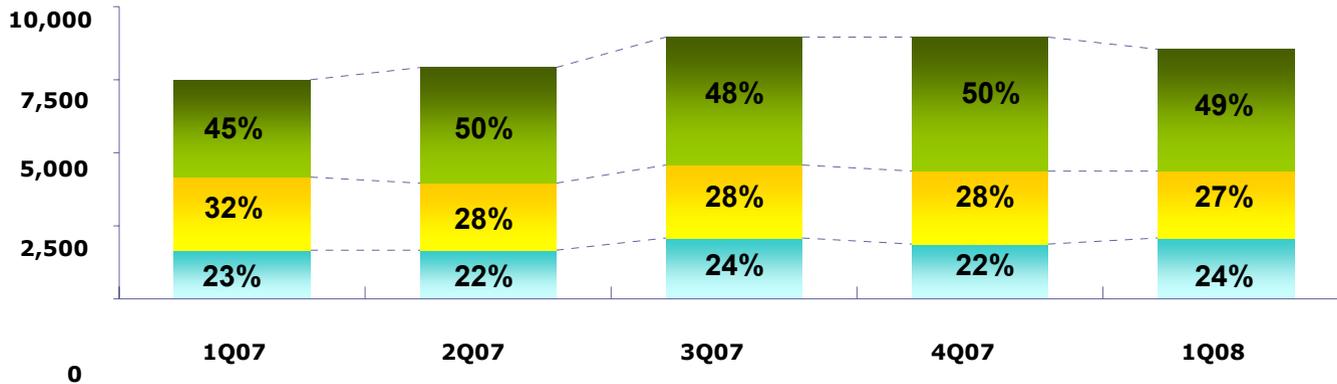
Quarterly Revenue by Regions

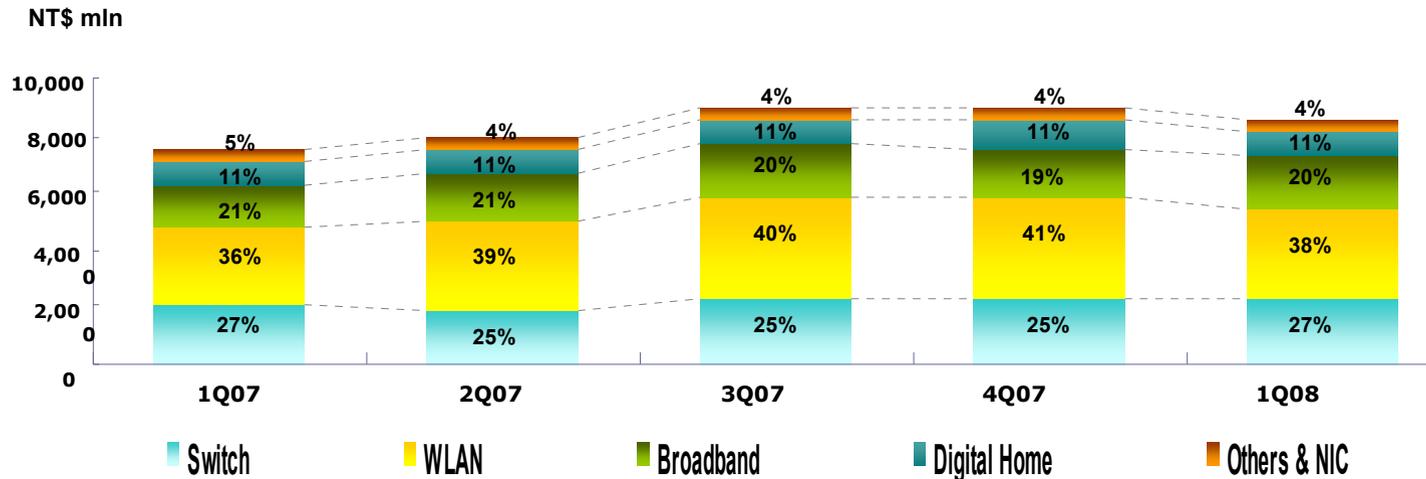




Quarterly Revenue by Products Brand Only
